BIDDER QUESTIONS/REQUESTS FOR CLARIFICATION

1. Q: Our largest beds that a F550 can handle will be able to hold between 5-7 cubic yards. To get to that 10-12 cubic yard mark we would have to do a single axle dump truck." **Is 5-7 cubic yard capacity, ok?**

A: **5-7 cubic yards would be fine**

2. Q: We use a hydraulic pin on tailgate spreader that uses an auger to feed the spinner. You would dump the salt into the bed open the tailgate and slightly raise the bed to feed the spreader." **Would this be an option we can use?**

A: **We would prefer the conveyer belt option, if available**

3. Q: We can put liquid applications on which would spray your material as is was going through the tailgate spreader. We would call this a slurry which works very well. We do not make any system that can mix brine on the truck. For us to consider it a brine it must be a saltwater mix which is mixed at 23.3%. We do make brine makers but that would be a separate piece of equipment. **Would this liquid applications work for our us?**

A: **This liquid application would work**

4. Q: Would you like the bed made out if High Tensile Steel or Stainless Steel? Stainless steel is recommended if using in snow.

A: **Stainless steel is preferred**
